CONTRACT AWARD NOTICE

Ordering Party - Gdańsk University of Technology, Faculty of Electronics, Telecommunications and Informatics, acting on the basis of art. 11 sec. 5, point 1 of the Act of September 11, 2019, Public Procurement Law (i.e. Journal of Laws 2019, item 2019, as amended), informs about the intention to award the contract and invites you to submit offers for the supply of HPHT nanodiamond powders with nitrogen color centers for The Faculty of Electronics, Telecommunications and Informatics of the Gdańsk University of Technology.

1. Detailed description of the subject of the contract
 - 1) The subject of the contract is the delivery to the registered office of the Ordering Party of HPHT nanodiamond powders with nitrogen color centers for the project "New photonic and quantum devices using non-linear and coherence phenomena in color centers in a diamond; OPUS 11 ", implemented at the Faculty of Electronics, Telecommunications and Informatics of the Gdańsk University of Technology.
 - 2) CPV classification code: 14521140-2 dust or powder of precious stones. A detailed description of the subject of the contract is attached as Appendix 2 to this announcement.
 - 3) The subject of the contract includes delivery to the seat of the contracting authority: Gdańsk University of Technology, Faculty of Electronics, Telecommunications and Informatics, ul. Narutowicza 11/12, 80-233 Gdańsk, WETI A building (No. 41), room 116.
 - 4) The subject of the contract was defined by indicating objective technical and quality characteristics.
2. Description of the method of preparing the offer
 1. The offer should be prepared in accordance with the model offer form constituting Annex 1 to this announcement.
 2. The offer may be submitted in writing or in an electronic form with a qualified electronic signature or in an electronic form with a trusted signature or a personal signature. The offer must contain the signature of the person (s) authorized to act on behalf of the contractor (a power of attorney should be attached to the offer, in accordance with the requirements of the Civil Code). All attachments to the offer, constituting declarations, should also be signed by an authorized representative. The scope of the entrepreneur's representation must result from the documents presented by the contractor.
 3. When submitting an offer in writing, the Contractor should submit it in a non-transparent, sealed and labeled envelope: "Offer in the procedure for the supply of nanodiamond HPHT with nitrogen color centers for WETI PG, case reference: ZZ/200/009/D/21". The Contractor, when submitting an offer using electronic means of communication, should enter in the subject of the e-mail the following designation: "ZZ/200/009/D/21 offer in the procedure for the supply of nanodiamond HPHT with nitrogen color centers for WETI PG".
3. Description of the method of calculating the offer price
 - 1) The offer price is the price specified in the offer form constituting Appendix 1 to this announcement.
 - 2) The price must be specified in Polish zlotys.
 - 3) The bid price should be specified in gross value (including VAT), with a precision of two decimal places.
 - 4) The price of the offer should be calculated taking into account all pricing elements related to the correct and timely execution of the contract that will arise in connection with the performance of the contract and the conditions and requirements set by the Ordering Party.
4. Place and deadline for submitting offers:
 - 1) The deadline for submitting offers expires on 03/15/2021 at 10:00.
 - 2) Offers must be submitted in writing to the address of Gdańsk University of Technology, Faculty of Electronics, Telecommunications and Informatics, 80-233 Gdańsk, ul. G. Narutowicza 11/12, WETI A building, room 116 or by e-mail to the following address: logistyka@eti.pg.edu.pl.

- 3) The economic operator may ask the contracting authority to explain the content of the notice by electronic means to the e-mail address: logistyka@eti.pg.edu.pl.
 - 4) Offers sent after the deadline will not be considered.
 - 5) The contractor may, before the deadline for submitting tenders, change or withdraw its tender.
 - 6) Each contractor may submit only one offer and propose only one price.
5. Criteria for evaluation of offers
- When selecting a tender, the contracting authority will use the following tender evaluation criterion:
- 1. Gross price of the subject of the contract - 90 points**
 - 2. Years of experience in manufacturing diamond products - 10 points**

Only the offers that are not rejected are subject to evaluation.

The contracting authority will sum up the points awarded in the criterion gross price of the subject of the contract and the number of years of experience in manufacturing nanodiamond products. The offer may receive a maximum of 100 points.

$$P = P_c + P_d$$

where:

P - total number of points for the offer under consideration

P_c - number of points obtained in the criterion "Gross price of the subject of the contract"

P_d - the number of points obtained in the criterion "number of years of experience in the production of diamond products"

The method and principles of evaluation of offers according to individual criteria.

5.1 Criterion: "Gross price of the subject of the contract" - 90 points.

The total gross price of the offer in PLN is assessed.

The contracting authority will grant the tender with the lowest price points calculated according to the formula:

$$P_c = \frac{C_n}{C_b} \times 90$$

where:

P_c - number of points awarded to the examined offer according to the "price" criterion;

C_n - the lowest gross price among valid, not rejected bids in PLN;

C_b - gross price of the evaluated offer in PLN;

90 - weight of the criterion.

The calculations will be made by the contracting authority with an accuracy of two decimal places.

5.2 The criterion "number of years of experience in the production of diamond products" - 10 points.

- a) the number of years of experience required by the ordering party in the production of diamond powders, at least 3 years.
- b) the number of years of experience in the production of diamond products resulting from the offer submitted by the contractor will be assessed.
- c) the evaluation of the offer in terms of this criterion will be carried out according to the following rules:
 - an offer with the number of years of experience in the production of diamond products required by the ordering party equal to 3 years 0 points.
 - an offer with the number of years of experience in the production of diamond products required by the contracting authority over 3 years 10 points

The contractor submits a declaration of compliance with the above requirements on the tender form. The contracting authority reserves the right to request from contractors documents confirming compliance with the requirements for participation in the procedure in question.

6. The contracting authority reserves the right to cancel the procedure at any time without giving reasons.

7. The contracting authority will sign a contract with the selected contractor, constituting Appendix 3.
8. Information clause regarding the processing of personal data and the free movement of such data.
 - 1) Pursuant to Art. 13 sec. 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016. on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (General Data Protection Regulation) (Journal of Laws of the EU L of 2016 No. 119, p. 1, amended: Journal of Laws UE. of 2018 No. 127, p. 2), hereinafter referred to as "GDPR",
The contracting authority informs that:

 - c) your personal data will be processed on the basis of art. 6 sec. 1 lit. c GDPR for the purpose related to the public procurement procedure for the supply of nanodiamond HPHT with nitrogen color centers for the Faculty of Electronics, Telecommunications and Informatics of the Gdańsk University of Technology, case no. : ZZ/200/009/D/2021, conducted pursuant to art. 11 sec. 5, point 1 of the Act of September 11, 2019 - Public Procurement Law (i.e. Journal of Laws of 2019, item 2019, as amended),
 - d) the recipients of your personal data will be persons or entities to whom the documentation of the procedure will be made available pursuant to art. 18 of the Act of September 11, 2019 - Public Procurement Law (Journal of Laws of 2019, item 2019, as amended),
 - e) your personal data will be stored for a period of 4 years from the date of completion of the contract award procedure, and if the duration of the contract exceeds 4 years, the storage period covers the entire duration of the contract. Documentation of public procurement procedures financed with funds from the European Union (EU) funds will also be kept for the period resulting from contracts for co-financing projects financed with funds from the EU,
 - f) the obligation to provide your personal data directly concerning you is a statutory requirement specified in the provisions of the PPL Act, related to participation in the public procurement procedure; the consequences of not providing specific data result from the PPL Act;
 - g) in relation to your personal data, decisions will not be made in an automated manner, in accordance with art. 22 GDPR,
 - h) you have:
 - based on Article. 15 GDPR, the right to access your personal data;
 - based on Article. 16 of the GDPR, the right to rectify your personal data (the exercise of the right to rectification may not result in a change in the result of the public procurement procedure or a change in the provisions of the contract to the extent inconsistent with the PPL Act and may not violate the integrity of the protocol and its attachments.);
 - based on Article. 18 GDPR, the right to request the administrator to limit the processing of personal data, subject to the cases referred to in art. 18 sec. 2 GDPR (the right to restriction of processing does not apply to storage, to provide legal remedies or to protect the rights of another natural or legal person, or for reasons of important public interest of the European Union or a Member State.);
 - the right to lodge a complaint to the President of the Personal Data Protection Office, if you feel that the processing of your personal data violates the provisions of the GDPR;
 - i) you are not entitled to:
 - in connection with Art. 17 sec. 3 lit. b, d or e GDPR the right to delete personal data;
 - the right to transfer personal data referred to in art. 20 GDPR;
 - based on Article. 21 GDPR, the right to object to the processing of personal data, as the legal basis for the processing of your personal data is art. 6 sec. 1 lit. c GDPR.
 - 2) Additionally, pursuant to Art. 19 paragraph 4 of the Public Procurement Law, the Awarding Entity informs about the limitations referred to in Art. 19 paragraph 2 and 3 and art. 75 of the Public Procurement Law:
 - a) if the Contractor exercises the right to obtain confirmation as to whether personal data concerning him are being processed, the Ordering Party will be entitled to request from the Contractor additional information specifying the request (e.g. name or date of the completed contract award procedure);

b) if the Contractor exercises the right to limit the processing of his personal data, the Ordering Party will be entitled to process this data until the end of the procedure for the award of the contract.
